RC-UN-NER and MNC Balika Mahavidyalaya have agreed to the following:

1. **Purpose:** It is the MOU for the cooperating parties to give on the development of the college in the field of Education, Science Culture and Environment.

2. Areas of Cooperation:

- a) MNC Balika Mahavidyalaya has agreed to assist RC-UN-NER for promoting UN/UNESCO programmes in the college jointly.
- b) MNC Balika Mahavidyalaya will provide excute the activities/programmes of RC-UN-NER while RC-UN-NER will support the GC to execute it.
- c) MNC Balika Mahavidyalaya will provide RC-UN-NER its Conference Hall/Manpower etc, for the UN/UNESCO programmes to held in the college.
- d) RC-UN-NER will set up a UN reading library at MNC Balika Mahavidyalaya while College shall provide a space exclusively for it and will send its feedbacks reports to RC-UN-NER quarterly.
- e) MNC Balika Mahavidyalaya may nominate a person from its college for the State/National/International conferences of UN/UNESCO as part of delegations of RC-UN-NER.
- f) MNC Balika Mahavidyalaya and RC-UN-NER shall promote the activities of International Youth Hostel for the welfare of the faculty/staff/students of the college.
- g) MNC Balika Mahavidyalaya may facilitate and academic enrolment in the college for the benefit of the inmates/children of the senior officials of RC-UN-NER to acquire a better quality education if seat will be available.
- h) MNC Balika Mahavidyalaya and RC-UN-NER will support and cooperate to each other inundertaking any Study/Research related to sustainable development activities in Assam.

General Provision:

The MoU shall be effective upon signature by both the parties for a period of 5 years from the date of signature. The MoU may be extended beyond the period upon mutual consent of the parties.

The MoU may be terminated by RC-UN-NER or by MNC Balika Mahavidyalaya upon written notice to the other party and shall terminate 30 days after receipt of such notice from the parties.

Without prejudice to the foregoing steps shall be taken to ensure that the information of the MoU will not compromise or discriminate against any of the activities or programme undertaken within the MoU framework.

Amendment:

The MoU may be amended at any time by written agreement of both the parties.

Settlement of Disputes:

Any dispute controversy of claim arising out of the MoU or the breach termination or invalidity thereof, which can not be settled through direct negotiations, will be amicably settled through reconciliation.
